Each partner will service a specific territory and will help ensure that year round, people will be able to receive an NLP training course endorsed by NLP figurehead, John Grinder.

Benefits of being an Authorised Training Partner

All organisations that become authorised training partners receive the following benefits:

- Receive the exclusive right to deliver the Graduate Certificate in NLP for a specific geographical region.
- At least one course unit per year is run by course founders and NLP trainers Inspiritive.
- Inspiritive undertakes additional marketing activities to promote courses on behalf of its licensees.

What type of organisations become Authorised Training Partners?

Typically the sorts of companies that become Authorised Training Partners:

- Have an interest in providing NLP training, but currently may not run courses in this field.
- Are training organisations in the fields of:
 - Change Management
 - Business Psychology
 - Business Process Re-engineering
 - Ericksonian Hypnosis
 - Cognitive Therapy
 - Training individuals to be business coaches
 - Project Management
 - NLP.

Requirements for an Authorised Training Partner

Each year Inspiritive is approached by organisation to license it's training materials, but only chooses those companies that it feels can deliver the complete training experience to the student. All organisations holding authorities for the training have met the following criteria:

- Authorised training organisations must have at least one Inspiritive certified trainer who has undertaken the 'NLP Graduate Certificate Trainers course' as well as the 'NLP Graduate Certificate'. These trainers will be attached to the training organisation and will need to undertake training updates on a regular basis.
- The authorised training organisation's training facility must be approved by Inspiritive to provide training for at least 20 people.
- Each authorised training organisation needs to run at least 2 Graduate Certificate Courses per annum.

The cost of undertaking the training to be eligible to become an Authorised Training Partner is payable at the published prices and in the published time frames for all course participants.

The fees for Authorised Training Partnership are equivalent to 17% of the course fee per enrolled student charged by the Authorised Training Partners where the course fee is AU\$5000.00 or more for each half of the Graduate Certificate in NLP or \$850.00 per enrolled student where the fee is less than AU\$5000.00.

The license fee is payable per student taking the training and is paid as a percentage of the agreed student fee.

Frequently Asked Questions

Does the training organisation have to undertake the student certification?

Inspiritive is the only body registered to issue a Graduate Certificate NLP. Inspiritive will manage the written assessment and certification process directly with the students. Practical assessment takes place in the training organisation venue at the end of each part of the Graduate Certificate. Initially Inspiritive will provide an assessor for a negotiated day rate.

What happens when somebody contacts Inspiritive to go on a training course?

Anybody enquiring on a course will be automatically directed to their nearest training partner by Inspiritive. The applicant retains the right to choose their location subject to availability.

What happens if one of the trainers leaves?

First, Inspiritive is able to provide certified trainers to take courses. Second, the licensee is protected since the trainer's certification is only valid when working for the Authorised partner. This means your investment in trainers will not be wasted.
